# Manulife Global Fund - Asia Pacific REIT Fund

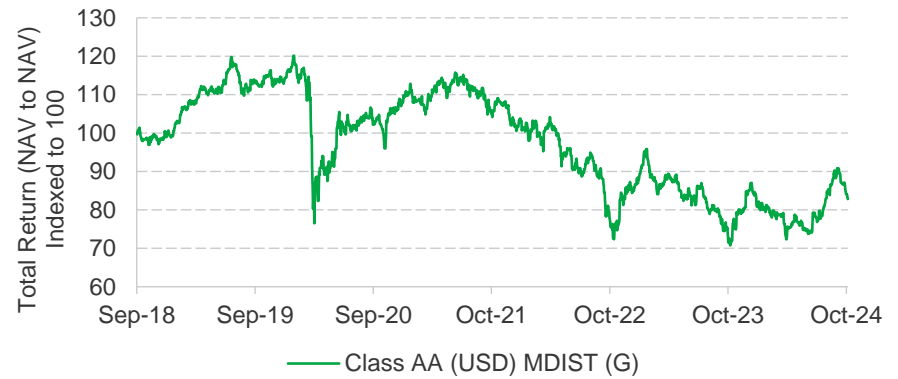
## Investment Objective
