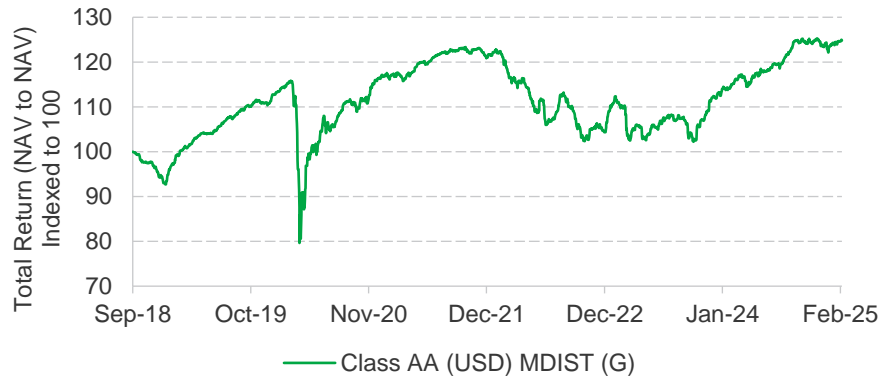
Manulife Global Fund - Preferred Securities Income Fund
