Manulife Global Fund - Sustainable Asia Bond Fund

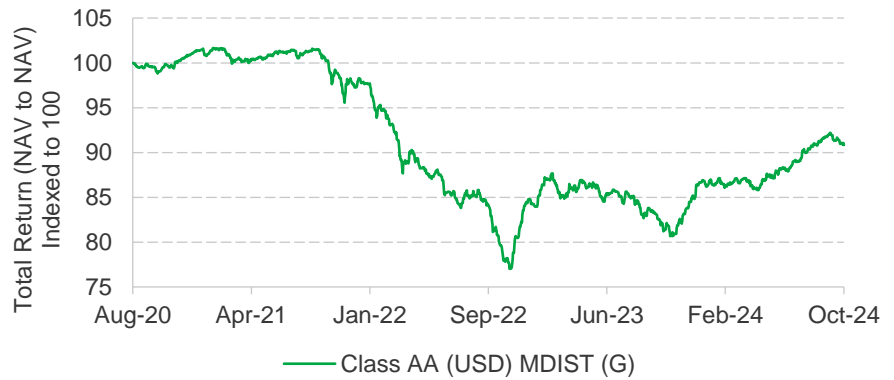
Investment Objective⁻
